Staff Report

COVID Update – The County of Santa Clara, the State and OSHA have essentially lifted all the restrictions. But staff will continue to proceed with caution. The Bar has opened (Sun, T, W, TH, F, Sat from 2-8pm), and the hall is hosting meetings (Posts, Auxiliaries, NA & AA, Blood Drives, and Karate Classes). The first memorial is scheduled July 10.

Bathroom Construction – The planned Bathroom Remodel is complete and has passed city and health department inspections. Total cost for was \$223,952.50 - \$1,047.50 under budget. However, staff is working with Toni Bowles from Neon Exchange to add décor to the bathrooms. This will include mirrors and military themed décor. Toni is donating her labor and donations have been received to cover the materials costs.

Fundraising – Current fundraising efforts will go toward the Bathroom décor. \$1,725 has been donated since the last meeting. Donors include:

Health Department Update – Since the last meeting, the Health Department has signed off on the bathroom. The next step is to split apart the kitchen and bar permits, as requested by the Health Department. However, further clarification from the Health Department says since the kitchen is only used for private events (post dinners, private parties, etc.) it doesn't need a separate permit yet. When the kitchen is remodeled and made available for outside chefs or to make food for public sale, then we'll need a separate permit. Until then we will operate as we have been.

June 21, 2021

CSDA Grant – Last month, the Board authorized the Executive Director to apply for Special District Technology Grant through CSDA for \$3,000 and match the grant with another \$3,000. A grant was submitted before the June 15, 2021 deadline, but there hasn't been any response yet.

Conference Scholarships – Staff has applied for scholarships from CSDA for up to \$1,500 and SCCSDA general scholarship so that staff and board members can attend the annual conference in the fall. But there is no response yet.

Marketing – Staff continues to maintain the Web Site (sscvmd.org) and Facebook (Gilroy Veterans Hall) pages as well as have a presence in Nextdoor.com's Gilroy Veterans group (Military Veterans of Gilroy).

Staff Vacation – Christine will be on vacation July 2-5, 7-12, July 31-Aug. 9 and Aug. 19-22. Christine will make arrangements to make sure there is back up for the Hall.
